

## ABSTRAK

Siti Fatimah Fitria, Nim : 709341131. "Pengaruh Pendidikan dan Pelatihan Kewirausahaan Terhadap Prestasi Belajar Kewirausahaan Siswa Kelas XI TKJ SMK Dharma Patra Tahun Ajaran 2013/2014". Skripsi, Jurusan Pendidikan Ekonomi, Program Studi Pendidikan Tata Niaga, Fakultas Ekonomi, Universitas Negeri Medan.

Permasalahan dalam penelitian ini adalah apakah terdapat pengaruh antara Pendidikan dan Pelatihan Kewirausahaan dengan Prestasi Belajar Kewirausahaan siswa kelas XI TKJ SMK Dharma Patra. Populasi dalam penelitian ini adalah seluruh siswa kelas XI TKJ SMK Dharma Patra Tahun Ajaran 2013/2014 sebanyak 110 orang terdiri dari 3 kelas. Sampel yang digunakan adalah 55 orang siswa yang diambil secara acak yaitu 50% dari jumlah populasi. Instrument yang digunakan dalam penelitian ini adalah berupa angket dan dokumentasi.

Teknik analisis data yang digunakan adalah Korelasi Product Moment, uji normalitas dan uji hipotesis dengan menggunakan uji "t". Dari hasil perhitungan koefisien Korelasi variabel X dan Y diperoleh  $r_{hitung} = 0,578$  sementara  $r_{tabel} = 0,361$  pada taraf signifikan 95% dengan  $n=55$ . Dengan demikian pengaruh Pendidikan dan Pelatihan Kewirausahaan (Variabel X) dengan Prestasi Belajar Kewirausahaan (Variabel Y) dikategorikan sedang.

Untuk uji normalitas pendidikan dan pelatihan kewirausahaan (Variabel X)  $L_{hitung} = 0,0726$  sementara  $L_{tabel} = 0,1195$  dan untuk diuji normalitas prestasi belajar (Variabel Y)  $L_{hitung} = 0,1143$  sementara  $L_{tabel} = 0,1195$ . Dengan demikian dapat disimpulkan bahwa Variabel X dan Variabel Y berdistribusi normal.

Selanjutnya dalam pengujian hipotesis dengan uji t diperoleh  $t_{hitung} = 6,32$  sementara  $t_{tabel} = 1,67$ . Hal ini berarti  $t_{hitung} (6,32) > t_{tabel} (1,67)$  pada taraf signifikan 95% dan Alpha 0,05 dengan dk =  $n-2 = 55-2$ . Dengan demikian hipotesis yang mengatakan bahwa: "Terdapat pengaruh yang positif dan signifikan antara pendidikan dan pelatihan kewirausahaan dengan prestasi belajar kewirausahaan siswa kelas XI TKJ Dharma Patra Tahun Ajaran 2013/2014" dapat diterima.

## ABSTRACT

Script, economic education majors commercial, program the education study arrange of faculty of economic of university of medan.

The problem of the research is to find whether there is an Impression between Education and Training of Entrepreneur with the Achievement of the Entrepreneurship of the 2<sup>nd</sup> Year Student of TKJ SMK Dharma Patra in academic year 2013/2014.

This research aims to find out the Impression between Education and Training of Entrepreneur with the Achievement of the Entrepreneurship of the 2<sup>nd</sup> Year Student of TKJ SMK Dharma Patra in academic year 2013/2014. The population of the research are all the eleventh grade students of SMK Dharma Patra in academic year Of 2013/2014 as many as 110 students represented by 3 classes. The sample used in this research are 55 students which are taken randomly which is 50% from the total amount of the population from each class. The instrument used in this research are anquette and documentation.

The technique used in analyzing the data is the Correlation of Product Moment, normality test and hypothesis test by using "t" test. From result of the calculation of correlation coefficient of variable of X and Y, is gained  $r_{hitung} = 0,578$  where as the  $r_{table} = 0,361$  at the significant level of 95% by the n-55. There by, the impression between education and training of entrepreneur (Variable X) with the achievement of entrepreneurship (Variable Y) is categorized avaraged.

For the normality test of impression of entrepreneur (X Variable), the result of  $L_{hitung} = 0,0726$ , where as the result of  $L_{table} = 0,1195$ . Meanwhile the normality test of the achievement of the entrepreneurship (Y Variable) is gained that the  $L_{hitung} = 0,1143$  whereas the  $L_{table} = 0,1195$ . From those result, it can be concluded that the X variable and the Y variable have a normal distribution.

Here and after in hypothesis examination with the 't' test is obtained that the  $t_{hitung} = 6,32$  whereas the  $t_{table} 1,67$ . This means  $t_{hitung} (6,32) > t_{table} (1,67)$  at a significant level Of 95% and the alpha = 0,05 by dk = n-5 = n-55. Therefore, related to the hypothesis saying that: "There is a positive and significant correlation between the impression of the entrepreneur with the achievement of the entrepreneurship of the 2<sup>nd</sup> year student of TKJ SMK Dharma Patra in academic year of 2013/2014" is acceptable.
