

ABSTRAK

Rahel Novita Sari Nainggolan. NIM. 3123111066. Pengaruh Tingkat Pendidikan Orang tua Terhadap Minat Anak Melanjutkan Pendidikan Ke Perguruan Tinggi Di Desa Tanjung Mulia Kecamatan Air Putih Kabupaten Batu Bara.

Penelitian ini bertujuan untuk mengetahui bagaimana pengaruh tingkat pendidikan orang tua terhadap minat anak melanjutkan pendidikan ke Perguruan Tinggi di Desa Tanjung Mulia Kecamatan Air Putih Kabupaten Batu Bara. Penelitian ini dilaksanakan di Desa Tanjung Mulia Kecamatan Air Putih Kabupaten Batu Bara dengan populasi 348 keluarga. Sampel dalam penelitian ini adalah 10% dari jumlah populasi yaitu sebanyak 35 keluarga berdasarkan terdapatnya anak usia 14-18 tahun. Pengumpulan data yang digunakan adalah dokumentasi dan kuesioner. Alat untuk mengumpulkan data kuesioner/angket berisi pernyataan positif dan negatif dan penskoran dinilai menggunakan skala Likert. Teknik analisis data menggunakan rumus *Product Moment*. Hasil penelitian menunjukkan terdapat pengaruh dari tingkat pendidikan orang tua terhadap minat anak melanjutkan pendidikan ke Perguruan Tinggi di Desa Tanjung Mulia Kecamatan Air Putih Kabupaten Batu Bara. Setelah dilakukan analisis korelasi, diperoleh nilai koefisien korelasi r_{xy} sebesar 0,817 hal ini menunjukkan bahwa terdapat pengaruh dari tingkat pendidikan orang tua (X) terhadap minat anak melanjutkan pendidikan ke Perguruan Tinggi (Y) di Desa Tanjung Mulia Kecamatan Air Putih Kabupaten Batu Bara. Berdasarkan perbandingan t_{hitung} dan t_{tabel} , maka diketahui bahwa $t_{hitung} > t_{tabel}$, yaitu $t_{hitung} = 8,23$ sedangkan $t_{tabel} = 2,03$, maka Hipotesis alternative (H_a) diterima, yaitu terdapat pengaruh tingkat pendidikan orang tua terhadap minat anak untuk melanjutkan pendidikan ke Perguruan Tinggi.

This research aims to know how the effect of parents education level on children interest to continue the education to college level in Tanjung Mulia village of Air Putih sub district in Batu Bara regency. This research was held at Tanjung Mulia village Of Air Putih Sub District In Batu Bara Regency with 348 families of the population. The sample of this research was 10% of the total population was 35 families based on the presence of children 14-18 years old. The Collecting data of this research is the documentation and questionnaires. The Researcher use to instruments to collect the data were questionnaire contain of positive and negative statements and the scoring evaluated using Likert scale. The analysing data of this research used Product Moment formula. Result of this research showed there was the effect of parents education level on children interest to continue the education to college level in Tanjung Mulia village of Air Putih sub district in Batu Bara regency. After the correlation analyzing was held, the correlation coefficient r_{xy} values was 0.817 it was showed that there was the effect of parents education level (X) on children interest to continue the education to College Level in Tanjung Mulia Village Of Air Putih Sub District In Batu Bara Regency. Based on the comparison t_{count} dan t_{tabel} , so it was known that $t_{count} > t_{tabel}$, is $t_{count} = 8,23$, , while $t_{table} = 2.03$, so the alternative hipotesis (H_a) was accepted, that there is the effect of parents education level on children interest to continue the education to college level in Tanjung Mulia village of Air Putih sub district in Batu Bara regency.
