Jenis penelitian ini menggunakan penelitian deskriptif dengan pendekatan kuantitatif. Subjek penelitian terdiri dari 31 orangtua yang memiliki anak usia dini di Desa Lintong Ni Huta. Metode pengumpulan data dengan menggunakan angket.

Educational Institutions of ECED (Early Childhood Education and Development) are the most basic educational institutions making ECED institutions must be able to provide quality and services that meet the developmental needs of children. Parents are one of the parts involved in determining the child's school so that perceptions arise.

The aims of this study are (1) to understand how parents perceive ECED learning services in Lintong Ni Huta Village, (2) to understand how parents perceive ECED facilities in Lintong Ni Huta Village, (3) to understand how people perceive parents towards ECED infrastructure services in Lintong Ni Huta Village, (4) to understand how parents perceive ECED assessment services in Lintong Ni Huta Village, (5) to understand how parents perceive the level of achievement of ECED development in Lintong Ni Huta Village.

This type of research uses descriptive research with a quantitative approach. The research subjects consisted of 31 parents who had early childhood in Lintong Ni Huta Village. Methods of collecting data using a questionnaire.

In accordance with the research findings that parents' perceptions of learning services are stated to be good, parents' perceptions of facility services are stated to be good, parents' perceptions of infrastructure services are stated to be not good, parents' perceptions of assessment services are stated to be good, parents' perceptions of the service achievement of development is declared good.
