Thank you for your submission to F1000Research. We have noted a few issues with your manuscript (below) – once these are addressed we will be pleased to accept your article for publication.

Content: We feel that your manuscript is missing some information. Reviewers and readers must be able to verify and replicate your study from the level of detail you give. We endorse the **STROBE** guidelines for reporting cross-sectional studies, we suggest that you ensure the article adheres to the checklist and add any details that are missing. The comments in the manuscript provide some queries relating to the checklist, but these are not exhaustive.

Data availability: Thank you for providing your underlying data. We noticed that there is some data missing. Our publication model requires that we always ask the author to provide the raw data that support their findings. We believe that it is essential that others can see the raw data to be able to replicate your study and re-analyse and/or reuse the data (with appropriate attribution).

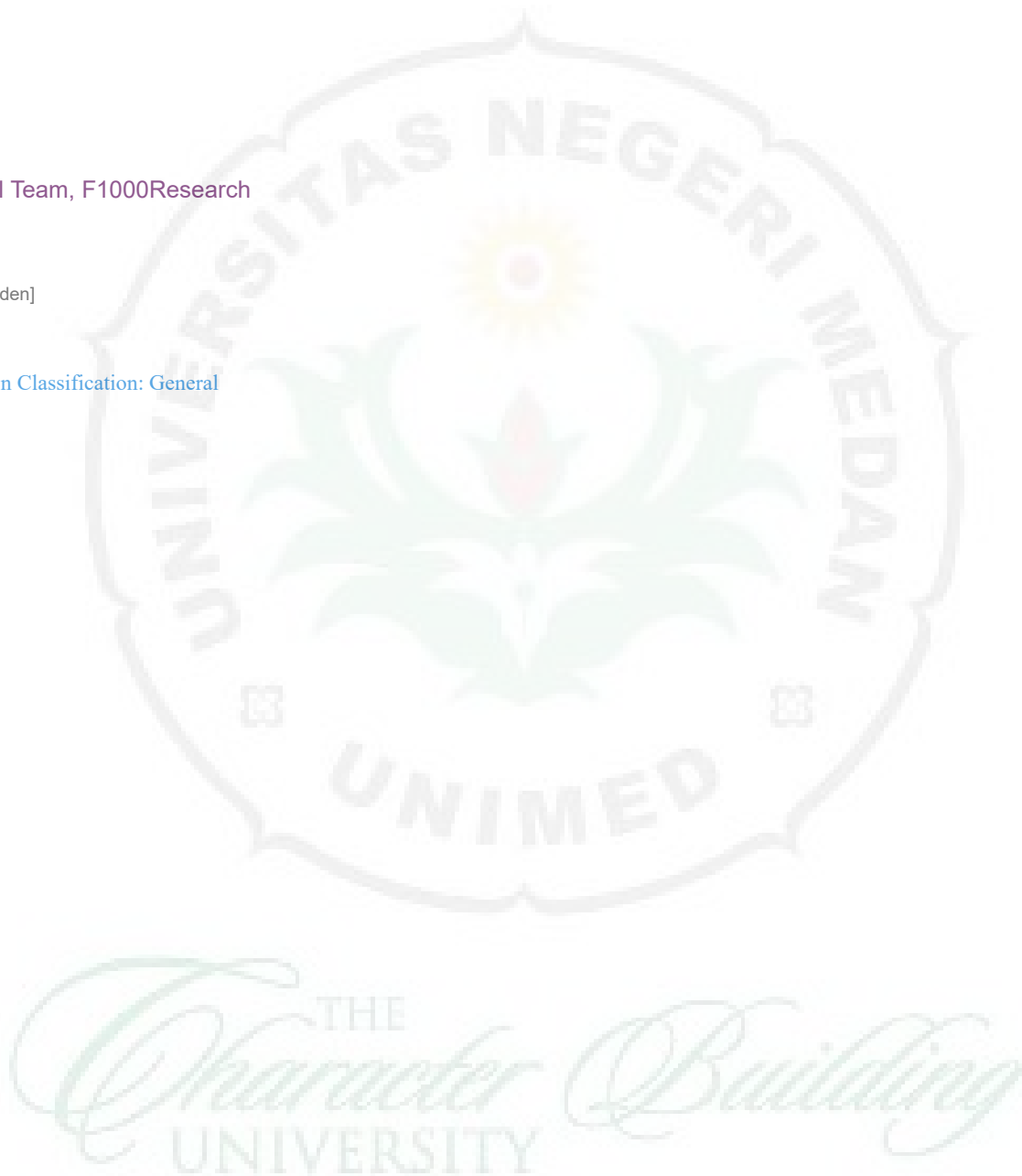
