Penelitian ini dilatar belakangi oleh permasalahan peran gender pada pola kerja perempuan pekerja di sektor informal. Penelitian ini bertujuan untuk menganalisis peran gender pada pola kerja perempuan pekerja sektor informal. Metode yang digunakan dalam penelitian adalah metode penelitian deskriptif dengan pendekatan kualitatif. Subjek penelitian diambil secara purposive yaitu dua orang penggali pasir dan batu kerikil. Data dikumpulkan dengan observasi dan wawancara, data dianalisis dengan langkah reduksi data, penyajian data, dan penarikan kesimpulan. Untuk penentuan keabsahan data digunakan credibility, transferability, dependability dan confirmability. Hasil penelitian menunjukkan alasan perempuan memilih bekerja sebagai penggali pasir dan batu kerikil karena keterbatasan ekonomi, dimana pendapatan suami tidak cukup untuk memenuhi kebutuhan ekonomi keluarga, sehingga istri harus ikut bekerja mencari nafkah. Dalam melaksanakan pekerjaan rumah tangga dan mencari nafkah secara bersamaan, tidak membuat mereka lupa akan kewajiban sebagai seorang istri dan ibu rumah tangga.

This research is motivated by the problem of gender roles in the work patterns of women workers in the informal sector. This study aims to analyze the role of gender in the work patterns of women workers in the informal sector. Data were collected by observation and interviews, data were analyzed by data reduction steps, data presentation, and drawing conclusions. The results show that the reason why women choose to work as sand and gravel diggers is due to economic limitations, where the husband's income is not enough to meet the economic needs of the family, so the wife has to work to earn a living. In carrying out household work and earning a living simultaneously, it does not make them forget their obligations as a wife and housewife.
