Penelitian ini bertujuan untuk mengetahui kreatifitas guru Penjaskes di SMA se-Kecamatan Kualuh Hulu Kabupaten Labuhanbatu Utara kreatif dalam Pembelajaran Penjaskes di masa pandemi Covid-19. Penelitian dilakukan di 5 sekolah di Kecamatan Kualuh Hulu Kabupaten Labuhanbatu Utara. Jumlah sampel pada penelitian ini berjumlah 10 orang. Dalam penelitian ini yang menjadi variabel yang diteliti adalah Kelancaran Berfikir, Keluwesan Berfikir, Originalitas, Elaborasi, Menilai. Penelitian ini merupakan penelitian deskriptif kuantitatif dengan menggunakan metode survey. Berdasarkan hasil penelitian yang dilakukan didapatkan hasil yaitu tingkat Kelancaran Berfikir sangat tinggi, Keluwesan Berfikir Sangat Tinggi, Originalitas Sangat Tinggi, Elaborasi sangat Tinggi dan Menilai juga sangat tinggi. Berdasarkan seluruh hasil tersebut dapat disimpulkan bahwa Tingkat Kreatifitas Guru Penjaskes pada Pembelajaran penjaskes saat pandemi Covid-19 di kecamatan kualuh hulu tergolong sangat tinggi.

*The purpose of this study was: To find out the creativity of Physical Education teachers in high schools throughout the Kualuh Hulu District, North Labuhanbatu Regency, to be creative in learning Physical Education during the Covid-19 pandemic. Based on all these results, it can be concluded that the Creativity Level of Physical Education Teachers in physical education learning during the COVID-19 pandemic in the Kualuh Hulu sub-district is very high.*
