Penelitian ini bertujuan untuk mengetahui besarnya Hubungan Antara Hasil Praktek Kerja Lapangan (PKL) dan Motivasi Dari Orang Tua Dengan Minat Berwirausaha Siswa Kelas XI Kompetensi Keahlian Teknik Kendaraan Ringan SMK Negeri 5 Medan Tahun Ajaran 2020/2021.

Metode penelitian deskriptif Korelasional. Populasi dalam penelitian ini peserta didik Kelas XITKR₁ dan XITKR₂ berjumlah 64 orang. Sampel penelitian diambil secara keseluruhan. Data penelitian ini dikumpulkan dengan angket dan metode dokumentasi nilai praktek kerja lapangan, data penelitian yang dijaring dengan angket adalah Motivasi Dari Orang Tua dan Minat Berwirausaha. Sedangkan untuk variable hasil praktek kerja lapangan dikumpulkan melalui metode dokumentasi nilai praktek kerja lapangan. Jumlah instrumen angket Motivasi Dari Orang Tua sebanyak 30 pernyataan dan 25 soal yang valid dengan reliabilitas 0,905 yang tergolong sangat kuat dan instrument angket Minat Berwirausaha sebanyak 30 soal dan 24 soal yang valid dengan reliabilitas 0,895 tergolong sangat kuat. Sedangkan untuk hasil praktek kerja lapangan didapat dengan dokumentasi nilai praktek kerja lapangan.

Hasil analisis data menunjukkan bahwa uji korelasi antara variable X₁ dan Y diperoleh $r_h = 0,555$ dan nilai r_t pada $\alpha = 0,05$ adalah 0,254. Hal ini berarti $r_h > r_t$, maka hipotesis diterima, dan untuk variable X₂ dan Y diperoleh $r_h = 0,447$ dan nilai r_t pada $\alpha = 0,05$ adalah 0,254. Hal ini berarti $r_h > r_t$, maka hipotesis diterima. Bahwa persamaan regresi $Y = 22,274 + 0,401 \cdot X_1 + 0,268 \cdot X_2$. Hasil analisis regresi sebagai berikut : $F_h = 18,184$ harga $F_t = 3,150$ pada taraf signifikan 5% sehingga $F_h > F_t$ ($18,184 > 3,150$). Sehingga dapat ditarik kesimpulan bahwa terdapat hubungan yang positif dan signifikan antara Hasil Praktek Kerja Lapangan (PKL) dan Motivasi Dari Orang Tua secara bersama sama terhadap Minat Berwirausaha Siswa Kelas XI Kompetensi Keahlian Teknik Kendaraan Ringan SMK Negeri 5 Medan.

ABSTRACT

This study aims to determine the magnitude of the relationship between the results of the Field Work Practice (FWP) and the Motivation of Parents with Entrepreneurial Interests in Class XI Students of Light Vehicle Engineering Skills Competence at SMK Negeri 5 Medan in the 2020/2021 Academic Year.

Correlational descriptive research method. The population in this study were students of Class XITKR₁ and XITKR₂ totaling 64 people. The research sample was taken as a whole. The research data was collected by using a questionnaire and the method of documenting the value of field work practices. The research data collected using a questionnaire were Parents' Motivation and Entrepreneurial Interest. As for the variables of field work practice results were collected through the method of documenting the value of field work practices. The number of motivational questionnaire instruments from parents is 30 statements and 25 valid questions with a reliability of 0.905 which is classified as very strong and the Entrepreneurial Interest questionnaire instrument is 30 questions and 24 valid questions with a reliability of 0.895 which is very strong. As for the results of field work practices obtained by documenting the value of field work practices.

The results of data analysis show that the correlation test between the variable X₁ and Y obtained $r_h = 0.555$ and the value of r_t at $\alpha = 0.05$ is 0.254. This means that $r_h > r_t$, then the hypothesis is accepted, and for the variable X₂ and Y obtained $r_h = 0.447$ and the value of r_t at $\alpha = 0.05$ is 0.254. This means that $r_h > r_t$, then the hypothesis is accepted. That the regression equation $Y = 22.274 + 0.401 \cdot X_1 + 0.268 \cdot X_2$. The results of the regression analysis are as follows: $F_h = 18,184$ the price of F_t price_t = 3.150 at a significant level of 5% so that $F_h > F_t$ ($18,184 > 3,150$). So it can be concluded that there is a positive and significant relationship between the results of the Field Work Practice (FWP) and the motivation of parents simultaneously on the Entrepreneurial Interest of Class XI Students of Light Vehicle Engineering Skills Competence at SMK Negeri 5 Medan.
