

ABSTRAK

Penelitian ini bertujuan untuk mengetahui : (1) Tingkat kepatuhan masyarakat dalam pendaftaran data kependudukan di Kelurahan Tanjung Sari (2) Alasan kepatuhan pendaftaran data kependudukan di Kelurahan Tanjung Sari.

Penelitian ini dilaksanakan di Kelurahan Tanjung Sari Kecamatan Medan Selayang Kota Medan pada bulan April-Mei 2023. Populasi dalam penelitian ini seluruh kepala keluarga di Kelurahan Tanjung Sari sebanyak 10.409 KK dengan sampel ditentukan dengan rumus *Slovin* sehingga diperoleh 174 KK. Teknik pengumpulan data dilakukan dengan kuesioner. Teknik analisis data adalah deskriptif kualitatif.

Hasil penelitian menunjukkan bahwa : (1) Tingkat kepatuhan masyarakat Kelurahan Tanjung Sari dalam pendaftaran data kependudukannya tergolong cukup baik (61.8%) sementara yang tidak patuh karena tidak ada waktu dan tidak perlu (2) Alasan kepatuhan masyarakat dalam pendaftaran data kependudukan yang paling dominan adalah masyarakat tidak mengalami kendala dalam pendaftaran dan alasan ketidakpatuhan karena tidak adanya saksi dan hukuman terutama dalam pendaftaran akta adopsi anak (pengangkatan anak), akta perceraian dan akta kematian.

ABSTRACT

This study aims to find out: (1) The level of public compliance in registering population data in the Tanjung Sari Village (2) Reasons for compliance with population registration data in the Tanjung Sari Village.

This research was conducted in the Tanjung Sari Village, Medan Selayang District, Medan City in April-May 2023. The population in this study was all heads of households in the Tanjung Sari Village as many as 10,409 families with a sample determined by the Slovin formula so that 174 families were obtained. The data collection technique was carried out using a questionnaire. The data analysis technique was descriptive qualitative.

The results showed that: (1) The level of compliance of the people of Kelurahan Tanjung Sari in registering their population data was quite good (61.8%) while those who did not comply because there was no time and it was not necessary (2) The most dominant reason for compliance in registering population data of the community was that the community did not experience problems in registration and the reason for non-compliance was due to the absence of witnesses and punishments, especially in the registration of certificates of adoption, divorce certificates and death certificates.
