

ABSTRAK

Penelitian ini bertujuan untuk melakukan evaluasi terhadap implementasi program sistem kredit semester di MTsN 1 Medan dengan model CIPP (Context, Input, Process, Output). Hal ini dikarenakan adanya permasalahan system kredit semester belum berjalan dengan optimal. Penelitian ini merupakan penelitian evaluatif dengan pendekatan deskriptif kualitatif menggunakan model CIPP. Teknik pengumpulan datanya dilakukan dengan observasi, dokumentasi, wawancara, kuisioner dan *Focus Group Discussion*. Berdasarkan hasil penelitian disimpulkan bahwasanya dalam evaluasi konteks yang mengevaluasi tujuan, masalah, keadaan lingkungan dan kebutuhan program SKS di MTsN 1 Medan sudah baik namun masih ditemukan beberapa kendala yang dihadapi. Kemudian dalam evaluasi input yang menilai perencanaan, daya dukung dan standar operasional prosedur terdapat masalah dalam perencanaan dan standar operasional prosedur. Sedangkan dalam evaluasi proses yang mengevaluasi implementasi pogram SKS dapat disimpulkan belum berjalan dengan baik. Dan terakhir pada evaluasi produk terlihat dampak positif dari adanya program namun program belum berjalan secara efektif sehingga berdasarkan kesimpulan dapat direkomendasikan untuk tetap menjalankan program SKS dengan memperbaiki perencanaan dan proses dengan disain yang ditawarkan berupa strategi perencanaan, alur SOP dan desain website sistem akademik SKS.

ABSTRACT

This study aims to evaluate the implementation of semester credit system program at MTsN 1 Medan with the CIPP model (Context , Input , Process , Output). This is due to problems with the semester credit system that has not run optimally. This research is an evaluative research with a qualitative descriptive approach using the CIPP model. Data collection techniques are carried out by observation, documentation, interviews, questionnaires and Focus Group Discussions. Based on the results of the study, it was concluded that the evaluation context which evaluates the objectives, problems, environmental conditions and needs of the SKS program at MTsN 1 Medan is good but there are still some obstacles encountered. Then in the input evaluation that assesses planning, carrying capacity and standard operating procedures are contained problem in planning and standards operational procedure . Meanwhile, in the process evaluation that evaluates the implementation of the SKS program , it can be concluded that it has not gone well. And finally, in the product evaluation, there is a positive impact from the program but the program has not been running effectively so based on the conclusions it can be recommended to continue running the SKS program by improving planning and processes with the designs offered in the form of planning strategies , SOP flow and website design of the SKS academic system.
