

ABSTRAK

Adelina Handayani, NIM 7103341002. Pengaruh Pemberian Motivasi Orangtua dan Minat Belajar Terhadap Prestasi Belajar IPS Terpadu Siswa Kelas VIII SMP Negeri 2 Delitua Tahun Pembelajaran 2013/2014. Skripsi.Jurusan Pendidikan Ekonomi.Program Studi Pendidikan Ekonomi. Fakultas Ekonomi. Universitas Negeri Medan 2014.

Masalah penelitian ini adalah rendahnya prestasi belajar siswa dan kurangnya minat belajar siswa dalam mengikuti pelajaran disekolah. Penelitian ini bertujuan untuk mengetahui pengaruh Pemberian motivasi orangtua dan minat belajar terhadap prestasi belajar IPS Terpadu siswa kelas VIII SMP Negeri 2 Delitua.

Populasi penelitian ini adalah seluruh siswa kelas VIII SMP Negeri 2 Delitua yang berjumlah 304 orang. Sampel penelitian berjumlah 80 orang diambil dengan teknik *random sampling*. Teknik pengumpulan data dilakukan dengan observasi,wawancara, dokumentasi dan angket. Uji validitas angket menggunakan rumus *Product Moment Person*, dan reliabilitas dihitung dengan menggunakan rumus *Cronbach Alpha*. Besarnya pengaruh variabel bebas(x) dengan variabel terikat menggunakan rumus regresi linear berganda,pengujian hipotesis (uji t, uji F, dan koefisien determinasi/ R^2) dengan taraf signifikan 95% dan $\alpha=0,05$.

Untuk Menguji Hipotesis Secara Parsial Digunakan Rumus uji-t dengan taraf signifikan 95% dan alpha 5%. Hasil yang diperoleh $t_{hitung} > t_{tabel}$ ($4.027 > 1,665$). Dengan demikian hipotesis pertama yaitu ada pengaruh yang positif dan signifikan Variabel Pemberian motivasi orangtua terhadap prestasi belajar IPS Terpadu siswa diterima. dan $t_{hitung} > t_{tabel}$ ($3.456 > 1,665$) Dengan demikian Hipotesis Kedua yaitu pengaruh yang positif dan signifikan Minat Belajar terhadap Prestasi Belajar IPS Terpadu siswa diterima.hasil uji F menunjukkan bahwa variabel Pemberian Motivasi Orangtua dan Minat Belajar terhadap Prestasi Belajar dapat dilihat ari nilai $F_{hit}>F_{tab}(64.763>3,12)$ Dengan demikian hipotesis ketiga yaitu pengaruh yang positif dan signifikan Variabel Pemberian Motivasi Orangtua dan Minat Belajar terhadap Prestasi Belajar IPS Terpadu siswa kelas VIII SMP Negeri 2 Delitua dapat diterima.

ABSTRACT

The problem in this research is the low of student achievement and a lack of student interest in the course at the school. This research aimed to determine the effect of parental motivation and interest in learning to student achievement at SMP Negeri 2 Delitua.

Population for this research is all of student at SMP Negeri 2 Delitua totalling 304. Sample for this research is 80 were taken in random sampling. Data was collected through observation, interviews, questionnaire and documentation. Validity was tested by using product moment, and reliability was tested by using Cronbach Alpha. correlation between the magnitude of the effect of independent variables (X) and dependent variable (Y), used multiple regression with significant 95% and $\alpha = 0,05$.

From the calculation of parents variables (X_1) on student achievement (Y) obtained $t_{hitung} = 4,027$ while $t_{tabel} = 1,665$ at significant level of 95% and $\alpha = 0,05$ thus the first hypothesis that a positive and significant between parents giving motivation on student achievement in SMP Negeri 2 Delitua can be accepted. From the calculation of the variable interest in learning (X_2) On Student Achievement (Y) obtained $t_{hitung} = 3,456$ while the $t_{tabel} = 1,665$ at significant level of 95% and $\alpha = 0,05$.thus the second hypothesis that a positive and significant regression between interest in learning on student achievement at SMP Negeri 2 Delitua can be accepted.

While the calculation of variable parents motivation and interest in learning of student achievement obtained $F_{hitung} = 64,763$ while the $F_{tabel} = 3,12$ at significant level of 95% and $\alpha = 0,05$. Thus the hypothesis third that a positive and significant regression between parent motivation and interest in learning on student achievement at SMP Negeri 2 Delitua can be accepted. Furthermore, from the calculation the coefficient of determination ((R^2)) of 0,627, which means 62,7% of student achievement (Y) is influenced by parent motivation concern(X_1) and student Interest (X_2)
