

ABSTRAK

Rahimul Harahap, Pengembangan Bahan Ajar Tematik Berbasis Budaya Lokal Pada Kelas IV Sekolah Dasar Di Kabupaten Padang Lawas Utara. Tesis. Medan: Program Pascasarjana Universitas Negeri Medan, 2019.

Tujuan dari penelitian ini adalah untuk mengembangkan bahan ajar tematik berbasis budaya lokal pada tema 6 cita-citaku sub tema 2 hebatnya cita-citaku. Jenis penelitian ini adalah penelitian pengembangan (R&D). Model penelitian yang digunakan adalah Model penelitian desain penelitian pengembangan model 4-D (Four D Models), yang terdiri dari empat tahap yaitu tahap defne (pendefinisian), design (perancangan), develop (pengembangan) dan disseminate (penyebaran) yang dikembangkan Thiagarajan. Subjek penelitian ini adalah siswa kelas IV SDN 103040 Batang Baruar Julu, SDN 101130 Purba Sinomba dan SDN 100930 Sibatang Kayu yang berjumlah 72 siswa dan objek penelitian tematik berbasis budaya lokal. Analisis data dilakukan dengan mengolaj data yang dilakukan pretest dan postes setelah uji coba produk dan Instrumen yang digunakan adalah lembar validasi, respon siswa, dan tes hasil belajar. Hasil penelitian menunjukkan bahwa : (1) bahan ajar yang dikembangkan sudah valid untuk digunakan dengan hasil validasi materi rata-rata 90%, validasi bahasa rata-rata 88% dan desain rata-rata 76 %, (2) bahan ajar yang dikembangkan dinilai efektif yang mencapai 81% ketuntasan siswa dilihat dari hasil belajar siswa. Disarankan bahan ajar tematik berbasis budaya lokal adalah alat untuk membantu dalam proses penyampaian pembelajaran, keberadaan guru masih sangat diperlukan sebagai fasilitator dan siswa tetap terlibat aktif dalam proses pembelajaran.

ABSTRACT

Rahimul Harahap, Development of Thematic Teaching Materials Based on Local Culture at the Fourth Grade of Primary Schools in North Padang Lawas District. Thesis. Medan: Postgraduate Program, Universitas Negeri Medan, 2019.

The purpose of this study was to develop thematic teaching materials based on local culture on theme 6 namely My Ideals of sub-themes 2, My Great Ideals. This type of research was development research (R & D). The research model used was the research design model for developing 4-D (Four D Models), consisted of four stages, namely the definition, design, develop and disseminate by Thiagarajan. The subjects of this study were the fourth grade students of SDN 103040 Batang Baruar Julu, SDN 101130 Purba Sinomba and SDN 100930 Sibatang Kayu totaling 72 students and objects of thematic research based on local culture. Data analysis was carried out by collecting data carried out by the pretest and posttest after the product trial and the instruments used were validation sheets, student responses, and learning outcomes tests. The results showed that: (1) the instructional materials developed were valid to be used with the results of material validation averaging 90%, language validation averaged 88% and design averages 76%, (2) the instructional materials developed were considered effective which reached 81% of students completeness seen from student learning outcomes. It was suggested that local culture-based thematic teaching material was a tool to assist in the process of delivering learning, the existence of teachers was still very much needed as a facilitator and students remain actively involved in the learning process.
