CHAPTER V CONCLUSION AND SUGGESTION

5.1 Conclusion

Additionally, the film addresses social issues related to racism and prejudice, reflecting both historical and contemporary contexts. These messages are embedded within the interactions and development of the main characters, Dr. Don Shirley and Tony "Lip" Vallelonga, showcasing the transformative power of mutual respect and understanding.
- 2. The meanings in the film are realized through various techniques. Through the use of Systemic Functional Linguistics (SFL), the film constructs its messages using dialogue that organizes information and guides audience interpretation. Visual techniques, analyzed through Kress and Van Leeuwen's visual grammar, complement the dialogue by enhancing storytelling through camera angles, shot distances, and visual composition. Integrating verbal, visual, and auditory elements through

Multimodal Discourse Analysis (MDA) creates a cohesive and engaging narrative, illustrating the interplay between semiotic resources. This multimodal approach ensures that the film's themes are effectively communicated to the audience.

3. The meanings are realized within their specific social context by reflecting the historical context of the 1960s American South, addressing the socio-cultural tensions of the era. The film uses multimodal elements to address themes of race, identity, and friendship, responding to social and cultural dynamics. The contextual and historical analysis demonstrates how the movie's socio-cultural and historical setting influences its portrayal of race and identity, highlighting the relevance and significance of these themes in modern society. By grounding the narrative in a specific historical period, the film underscores the ongoing relevance of these social issues.

5.2 Suggestion

1. Contribution to Novelty and Utilization of Research Findings

Additionally, educators can use this framework to teach students about the interplay between different semiotic resources in films, fostering a deeper understanding of media literacy.

2. Recommendations for Future Research

Future research can build upon the findings of this study by exploring the multimodal analysis of films from different genres and historical contexts. Comparative studies between films from diverse cultural backgrounds could provide further insights into the universal and culture-specific techniques used in filmmaking. Additionally, researchers could extend the application of this multimodal framework to other forms of media, such as advertisements, television shows, and digital media, to broaden the understanding of how complex messages are conveyed across different platforms.
