Penelitian ini bertujuan untuk (1) Mengidentifikasi ketersediaan fasilitas sosial di Kecamatan Siborongborong sesuai dengan ketersediaan jumlah penduduk.(2) Menganalisis persepsi masyarakat terhadap kebutuhan fasilitas sosial di Kecamatan Siborongborong. (3)Menganalisis persebaran fasilitas sosial di Kecamatan Siborongborong, Kabupaten Tapanuli Utara.

Penelitian ini dilaksanakan di Kecamatan Siborongborong Kabupaten Tapanuli Utara . Populasi secara fisik adalah Seluruh wilayah Kecamatan Siborongborong Kabupaten Tapanuli Utara dan populasi secara sosial nya adalah seluruh masyarakat di Kecamatan Siborongborong, yang berjumlah 52.745 jiwa. Sampel penelitian ini sebanyak 210 orang.Teknik Pengambilan data yang digunakan adalah Observasi,Kuesioner dan dokumentasi.dan teknik analisis data yang digunakan adalah Analisis Deskriptif dan Analisis Spasial

Hasil penelitian menunjukkan bahwa (1) ketersediaan fasilitas sosial di Kecamatan Siborongborong sesuai dengan ketersediaan jumlah penduduk (2) Persepsi masyarakat terhadap kebutuhan fasilitas sosial di Kecamatan Siborongborong menyatakan bahwa data keseluruhan adalah 45.095 (Cukup Baik) sehingga mereka merasa perlu adanya peningkatan fasilitas (3) persebaran penyebaran fasilitas sosial di Kecamatan Siborongborong menunjukkan ketidakmerataan, terutama antara daerah perkotaan dan pedesaan.

ABSTRACT

This study aims to (1) Identify the availability of social facilities in Siborongborong District according to the availability of the number of residents. (2) Analyze public perceptions of the need for social facilities in Siborongborong District. (3) Analyze the distribution of social facilities in Siborongborong District, North Tapanuli Regency.

This study was conducted in Siborongborong District, North Tapanuli Regency. The physical population is the entire area of Siborongborong District, North Tapanuli Regency and the social population is the entire community in Siborongborong District, which totals 52,745 people. The sample of this study was 210 people. The data collection techniques used were Observation, Questionnaires and documentation. and the data analysis techniques used were Descriptive Analysis and Spatial Analysis.

The results of the study showed that (1) the availability of social facilities in Siborongborong District is in accordance with the availability of the population (2) Public perception of the need for social facilities in Siborongborong District stated that the overall data was 45,095 (Quite Good) so that they felt the need for increased facilities (3) the distribution of social facilities in Siborongborong District showed unevenness, especially between urban and rural areas.
